The State of Texas Assessment of the LRGVDC Region's Radio Communications Capabilities -- Regional Communications Interoperability Exercise

On June 13-14, 2007, the State of Texas, National Emergency Response and Rescue Training Center (NERRTC) scheduled a test of the regions first responder's interoperable communication systems capabilities by conducting an Interoperable Communications Functional Exercise. The regional communications functional exercise was a one and a half day exercise.



The **SIMULATED** Weapons of Mass Destruction (WMD)/Terrorism Exercise is designed to help prepare jurisdictions for the consequence management functions in the first 12-24 hours after a terrorist WMD attack or disaster. The regional exercise was an assessment-based exercise conducted in the communities within the LRGVDC Council of Governments (COG) region with the focus on evaluating the regional horizontal and vertical communications operability and interoperability systems.

The exercise consisted of a designated number of exercise cells that included an Incident Command Post (ICP) which consisted of all the primary players from the first responder arena from all participating jurisdictions and the designated Emergency Operation Center's (EOC's). The participant's task was to: establish radio communications between local disciplines and mutual aid response entities, operate on different frequency bands, add additional communications components as necessary, and develop an incident communications plan as part of the response to the **simulated** catastrophic Weapons of Mass Destruction (WMD) event that took place at the Port of Brownsville.

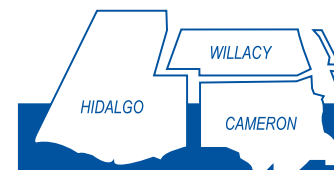
Past and current recipients of homeland security funding were required to participate. ALL other local, state and federal agencies were highly encouraged to do so as well. Several agencies prestaged communication equipment at the ICP, Brownsville Fire Station # 8. The number of agencies who participated in the exercise was an impressive (46) forty six by the end of day one. As expressed by NERRTC personnel who were extremely impressed, the number of agencies surpassed all other regions by far. All first responder agencies matched and exceeded the communication exercise tasks. Upon completion of the exercise, NERRTC assisted the jurisdictions in completing a post exercise report that the jurisdictions will

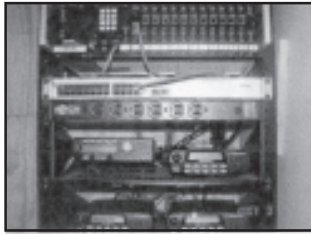

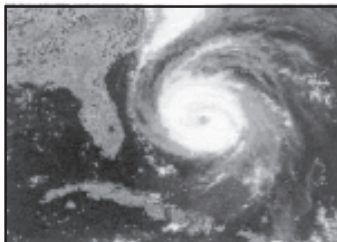

submit to GDEM for forwarding to Office of Domestic Preparedness (ODP) as per the requirements of the Homeland Security Exercise and Evaluation Program (HSEEP). The report will include the exercise events list, an exercise summary of events, and training observations made by subject matter experts addressing the ICP, EOC and any other responding emergency command or supporting node requested in the exercise drafting process. NERRTC Staff will also be providing a written post-exercise report to GDEM that will later be provided to the region's leadership 90 days after the completion of the exercise.



Preparing for Hurricane Season Your Safety—Your Responsibility First!

Hurricane Season is here... have a plan ready. June 1st marked the official start of the 2007 Hurricane Season. The first line of defense in protecting yourself, your family and your property comes from being informed and prepared for a tropical storm or hurricane in your area. Here are FEMA's top 10 tips for becoming "Hurricane Ready."



- **Know what problems you might face if a storm is approaching.** Are you in a storm surge area or an area that is flood-prone? Do you live in a mobile home? Is your area vulnerable to tropical storm force winds?

- **Create an emergency plan for you, your family or friends.** Make sure everyone is familiar with the plan and practice it at least once before a storm forms in the Gulf. The American Red Cross and Ready.gov have excellent information on developing your plans.

- **Build an emergency kit.** Include one for your home and one for your car in case you have to evacuate. Make sure to include cash, important papers such as mortgage and insurance information along with food items, water, medications, etc.

- **Have an individual or family communications plan.** Pick someone in another region as an emergency contact so people will know where you and your family are located. This plan will also help if you and your immediate family get separated during a storm event.



- **Plan for family members or others with special needs or disabilities.** Consider the medications or items specific to their needs in the emergency kit. If you don't have a car or need special transportation,

make arrangements with friends, neighbors or relatives for a ride. You can also contact your local emergency manager to find out what arrangements may be available. It's critical to have a plan ahead of time!

- **Know where to go if you are instructed to evacuate.** Do you have family or friends with whom you can stay? If making hotel reservations, make sure to confirm them.

- **Stay alert to weather information and listen to your local emergency managers.** Keep your gas tank full at all times. When they say it's time to evacuate, DO IT!

- **Be prepared to be on your own for several days whether you evacuate or not.** That may include being without electricity or clean drinking water. Take this into consideration when building your emergency kit.

- **Prepare your home and property for severe weather.** Suggestions include flood-proofing your home, securing your mobile home, and if outside of a flood area, building a safe room to protect from wind and tornadoes. Also, consider purchasing flood insurance now. There is a 30-day waiting period before the policy goes into effect. Go to Floodsmart.gov for details.

- **Include your pets in your planning.** It is critical to board them or take them with you. In either case, advance planning remains the key to your animal's health and safety and your peace of mind. The Humane Society provides excellent tips on preparing your pets for emergencies.

Youth Group Help Elderly

On June 11-14th a youth group from Saint John United Methodist Church from Austin, Texas traveled to the Lower Rio Grande Valley to assist the low-income elderly in the community with home repairs. The Area Agency on Aging networked with the local First United Methodist Church in McAllen to coordinate a site for the youth to do their missionary work.

A work site was chosen according to the area requested by the group, an elderly couple from the Alamo area in need of a ramp were chosen. Due to the elderly couple's disabilities, both much needed the ramp. The group replaced a pre-existing front ramp that was hazardous and did not meet the ADA standards. The group also completed other home repairs in addition to a 6x6 backdoor porch with a 16ft.ramp landing.

It was a first work experience and the first trip to the valley for the group, they stated that they really enjoyed doing the work and just knowing that they helped someone in need was enough reward for them. The last day of work ended with a homemade Mexican meal for the group, courtesy of the elderly couple. The group consisted of five youth, the youth pastor and two adult church members.

Criminal Justice Program

Criminal Justice Department held technical assistance workshops for potential grantees regarding the FY 2008 grant application process. There were several Criminal Justice Division fund sources reviewed and prioritized by the Criminal Justice Advisory Committee during the months of April, May and June of 2007. which were the Victims of Crime Act Fund, Violence Against Women Act Fund, Safe Drug Free in Schools and Communities Act Fund, Criminal Justice Planning Fund, and the Juvenile Justice Delinquency Prevention Act Fund. There were 32 grant applications submitted to the Office of Governor's Criminal Justice Division for the Lower Rio Grande Valley Development Council Region which consist of agencies within Cameron, Hidalgo and Willacy counties. The total amount requested from our region from all fund sources is \$4,155,019.
