- >> Launched in 2016
- Positively impacts 34 cities in the RGV
- Works closely with community service agencies, industry leaders and local governments to encourage efficient and cost-effective use of natural gas
- >> Supports long-term energy and financial savings for customers
- >> Promotes water conservation and reducing environmental emissions



Energy Efficiency Programs

Low-Income/Free Equipment:

 In conjunction with social service agencies, qualifying households can receive new, high-efficiency natural gas appliances installed by local, licensed contractor-partners.



Residential New Construction:

Rebates/Incentives for builders and homeowners of newly constructed residential homes.

Residential Retrofit:

 Rebates/Incentives for homeowners upgrading to higher-efficiency natural gas appliances or converting to natural gas service and installing natural gas appliances.



Commercial:

- Rebates/Incentives for various commercial appliances and systems.
- Energy saving equipment installed at no cost by a 3rd party vendor, CLEAResult.

Low-Income/Free Equipment Program

- >> Provides the purchase and installation of free, high-efficiency natural gas appliances to low-income, elderly and mobility-challenged customers.
- Referrals are verified and issued by our partner agencies.
