Who is Eligible?

You may be eligible if you meet the following criteria:

- Current Hidalgo County resident
- Economically impacted by COVID-19
- Low-income
- Currently renting
- Are at risk of losing your place of residence

What Assistance Will I Receive?

You can receive assistance on past rent due as far back as April 2020 and up to three months of future rent and utility costs.

What is the Rental Relief Program?

The Rental Relief Program is an assistance program designed to provide rental and utility assistance to qualifying Hidalgo County residents who have been adversely affected by COVID-19.

What does the Hidalgo County Rent Relief Program Cover?

Past due rent as far back as March 2020, and future rent for:

- Apartments
- Condos
- Houses
- Lots/land
