Mr. Jim Darling, Board Secretary called the meeting to order at 12:12 pm. Roll call was taken and a quorum was attained.

Chairman Darling moved to item #2: Consideration and Action to Approve Meeting Minutes (October 26, 2022). ***Mayor Norie Gonzalez Garza made a motion to approve the October 26, 2022, Meeting Minutes as presented. Mayor Rick Salinas seconded the motion, and upon a vote the motion carried unanimously.***

Upon conclusion of action on the minutes, Chairman Darling moved to Item 3: Public Comment, there being none, he moved to Item 4: Administration.

A. Consider Ratification of Executive Committee Action on Purchase of Real Property

Mr. Manuel Cruz, LRGVDC Executive Director was recognized and stated that this item is to consider ratifying Executive Committee action to purchase real property for the purpose of constructing a multimodal facility. He reminded the Board that at the October 26, 2022, meeting, the Board adjourned into executive session to discuss this item. Upon returning to regular session, the Board unanimously approved presenting the offer to purchase the property as presented at that time, which was for \$48,000 per acre. LRGVDC staff, legal counsel, and realtor, David Equity Realty, have been in communication with the seller on the transaction and have received a counteroffer, which was the original amount of \$65,000. The Realtor countered with \$52,500 and made the rollback taxes a strategy of the negotiation and the seller settled with \$52,500 per acre.

LRGVDC's lead attorney has been in communication with the Realtor and reviewed the information and the counters made from the seller and Realtor. Due to an unexpected quick turnaround in negotiations, the realtor and LRGVDC staff strongly recommended meeting with the Executive Committee prior to the December 14, 2022, regular scheduled Board Meeting. The Executive Committee met on November 14, 2022, to review, discuss, and consider the counteroffer of \$52,500 per acre. After due consideration, the Executive Committee unanimously voted to accept the counteroffer as presented with the stipulation of the 90-days to complete a successful feasibility study that will meet grant guidelines. Ratification of this decision is required by the full Board. ***Mayor Norie Gonzalez Garza made a motion to ratify the Executive Committee action on the purchase of real property. Commissioner David Garza seconded the motion, and upon a vote, the motion carried unanimously.***

B. Executive Session

1. Real Property Matter pursuant to Sec. 551.071 (attorney consultation) and Sec. 551.072 (purchase, exchange, lease, or value of real property) regarding certain real property located on North Milanos Road in the West Tract Subdivision, Weslaco, Texas

At 12:20 pm the Board adjourned into Executive Session.

2. Reconvene into Open Session to Consider Action, if any, on Items Related to Executive Session as Described Above

Regular session reconvened at 12:44 pm and Chairman Darling stated that no action will be taken from Executive Session.

C. Presentation on 2023 It's Time Texas Community Challenge

Ms. Selene Guerrero, South Texas Regional Director for ITT, was recognized and provided details about the 8-week program that is scheduled to begin on January 9, 2023. A press conference for the kickoff is scheduled at 10:30 am that day in Building B at the LRGVDC Main Campus. ***Upon conclusion of the presentation, Commissioner Ellie Torres made a motion for Board members to sign the 2023 It's Time Texas Community Challenge pledge. Councilman Johnny Garcia seconded the motion, and upon a vote the motion carried unanimously.***

D. Consideration and Action on Date and Time for Annual Report & Budget Committee Meeting

Mr. Cruz was recognized and informed the Board that the Annual Report is our service program that outlines our performance goals and outcomes. All members of the LRGVDC Board of Directors are included on this committee and there is no quorum requirement to conduct business at this meeting. The Annual Report & Budget will be placed on the January 25, 2023, Board & Membership Meeting agenda, therefore in order to make a recommendation, the committee must meet prior to that date. Mr. Cruz suggested scheduling a meeting on Thursday, January 12, 2023, at 12:00 noon with a GoToMeeting option. ***Mayor Norie Gonzalez Garza made a motion to schedule the Annual Report & Budget Committee meeting on Thursday, January 12, 2023, at 12:00 noon. Commissioner David Garza seconded the motion, and upon a vote the motion carried unanimously.***

E. Executive Director Report

1. Introduction of New Staff Members

Mr. Cruz informed the Board that Valley Metro hired Drivers Enrique Garcia, and Xavier Claudio, and the RGVMPPO welcomed Adriana Estrada as their Executive Assistant.

2. 2023 Board Meeting Schedule

Mr. Cruz presented a meeting schedule for 2023 similar to the 2022 schedule; meetings to be held on the last Wednesday of each month with the exceptions of no meetings held in July or November, and the December meeting scheduled on the 13th to accommodate the Thanksgiving and Christmas holidays. ***Commissioner Jacob Howell made a motion to approve the 2023 Board Meeting Schedule as presented. Councilman Johnny Garcia seconded the motion, and upon a vote the motion carried unanimously.***

3. Update on Regional News, Funding Opportunities, Trainings, and Legislation

Mr. Cruz informed the Board that the Texas Broadband Development Office wants to extend the deadline to finalize the FCC Broadband Coverage Map and recommends challenging the Map as incomplete. He stated that the Texas Association of Regional Councils (TARC) is spearheading this effort and will make sure the Board's comments are heard and sent to TARC. No Board Action required.

Upon conclusion of the Executive Director Report, Chairman Darling moved to item 5: Department Reports.

A. Community & Economic Development

Program Action Items

Mr. Rick Carrera, Director of Community & Economic Development was recognized and addressed the following items:

1. Consideration and Action to Approve solid Waste Advisory Committee (SWAC) Member

Mr. Carrera informed the Board that at their November 29, 2022, SWAC meeting the committee recommended Ms. Grace Gonzales from Pharr to serve on the committee as the Private Citizen representative. ***Mayor Norie Gonzalez Garza made a motion to approve Ms. Grace Gonzales as a Private Citizen representative for the SWAC as recommended. Commissioner Jacob Howell seconded the motion and upon a vote the motion carried unanimously.***

2. Consideration and Action to Approve Regional Water Resource Advisory Committee (RWRAC) Nominations for Institute of Higher Education and Small City Representatives

Mr. Carreras stated that at the RWRAC meeting held yesterday, the committee recommended Ms. Anabell Cardona to represent Higher Education, and Mr. Bobby Salinas from the City of Alamo to represent Small Cities on the committee. ***Councilman Johnny Garcia made a motion to approve Ms. Anabell Cardona to represent Higher Education and Mr. Bobby Salinas from the City of Alamo to represent Small Cities on the RWRAC. Commissioner Ellie Torres seconded, and upon a vote the motion carried unanimously.***

Program Status Reports

Mr. Carrera thanked the Small Business Administration for attending the 1st Annual Vet Fest held on Wednesday, November 16, 2022, noting that as an Economic Development District, the LRGVDC encourages entrepreneurship at all levels and all types. He also thanked the Veterans Business Outreach and the Procurement Technical Assistance Center from UTRGV, who shared information and participated in the event. He then summarized department activities that have occurred since the October meeting.

Mr. Carrera then yielded the floor to Chairman Darling to give the reservoir level report. Chairman Darling stated that the combined storage is 31.02% as of December 3, 2022, and cautioned municipalities to closely monitor these reports because when the reservoir storage drops below 30%, drought conservation measures are activated. Chairman Darling also informed the Board about the Border 2025 agreement between the US EPA, TCEQ, the State of Texas and their counterparts in Mexico. Border 2025 has projects funded on both sides of the river for economic development, water management, and water quality initiatives on the table with funding from the North American Development (NAD) Bank. He encouraged members that have projects of this nature to contact himself or Mr. Carrera so they can meet the deadline of the end of December 2022.

B. Health & Human Services

Ms. Margarita Lopez, Director of Health & Human Services was recognized and informed the Board that the status reports cover fiscal year October 1, 2021, through September 30, 2022. She summarized the services provided during that timeframe, and also highlighted events that have taken place since the last Board meeting.

Mr. Perez informed the Board that as per Task HS1.1 of the Statement of Work with the Public Safety Office's HSGD, the HSAC and LRGVDC program Staff shall review the policy and procedures for grants annually. After conducting a thorough review, the committee determined that no revisions were needed at this time. The Policies and Procedures Manual was provided in the meeting packet for review. ***Mayor Norie Gonzalez Garza made a motion to approve the HSAC Policies & Procedures for HSGD Grants for FY 2023-2024 as presented. Councilman Johnny Garcia seconded the motion, and upon a vote the motion carried unanimously.***
2. Consideration and Action to Approve Homeland Security Advisory Committee (HSAC) Recommendation on Updates to HSAC Bylaws
Mr. Perez informed the Board that as per Task HS1.1 of the Statement of Work with the Public Safety Office's HSGD, the HSAC and LRGVDC program staff shall review the bylaws annually. After conducting a thorough review, the committee determined that no revisions were needed at this time. The bylaws were provided in the meeting packet for review. ***Commissioner Ellie Torres made a motion to approve the HSAC bylaws as presented. Councilman Johnny Garcia seconded the motion, and upon a vote the motion carried unanimously.***
3. Consideration and Action to Approve Homeland Security Advisory Committee (HSAC) Recommendation on Updates to Review Sheet for HSGD FY 2023-2024
Mr. Perez informed the Board that as per Task HS1.1 of the Statement of Work with the Public Safety Office's HSGD, the HSAC and LRGVDC program staff shall review the grant review sheet annually. The updated Review Sheet was provided in the meeting packet for review. ***Mayor Norie Gonzalez Garza made a motion to approve the Review Sheet for HSGD FY 2023-2024 as presented. Commissioner Ellie Torres seconded the motion, and upon a vote the motion carried unanimously.***
4. Consideration and Action to Approve Criminal Justice Advisory Committee (CJAC) Recommendation on Updates to CJAC Review Sheet for CJD FY 2023-2024
Mr. Perez informed the Board that as per Task cCJ1.1 of the Statement of Work with the Public Safety Office's CJD, the CJAC and LRGVDC program staff shall review the grant review form annually. The updated Review Sheet was included in the meeting packet for review. ***Commissioner Jacob Howell made a motion to approve the CJAC Review Sheet for CJD FY 2023-2024 Grants as presented. Councilman Johnny Garcia seconded the motion, and upon a vote the motion carried unanimously.***
5. Consideration and Action to Approve Appointment of Criminal Justice Advisory Committee (CJAC) Members

Upon conclusion of action, Mr. Perez summarized the status reports and noted that recently a seat on the CJAC became vacant. Nominations to fill this seat will be presented at the next Board meeting.

Mr. Cruz informed the Board that the HLS grants application process recently opened on e-grants on the Texas Office of the Governor's website. These grants are designed to benefit law enforcement, fire departments, and emergency management. Mr. Perez had notified local municipalities of this opportunity for funding and added that the deadline to apply is February 22, 2023.

Mr. Luis Diaz, RGVMPO Assistant Director was recognized and announced that the RGVMPO is the recipient of this year's Association of Metropolitan Planning Association's (AMPO) award for Excellence in MPO Staff Achievements. AMPO is the national association of MPO's and is comprised of over 245 MPO members nationwide. The RGVMPO staff was selected by the AMPO Board of Directors for success through the MPO Merger three years ago, and staff accomplishments in completing long range plans, development of regional transit plans, regional bike/ped plans and establishing staff to address and meet the demands of the regional planning needed for the new RGVMPO in such a short time frame. The RGVMPO staff was recognized for the award while attending the national AMPO conference in Minneapolis, Minnesota.

The Annual Report outlines LRGVDC's 2023 performance goals and 2023 budget for the current year as well as productivity outcomes for FY2022.

Budget Summary:

- 2023 Annual Budget is \$38,766,329: reflecting an increase of \$4,645,985 from the 2022 budget due to additional funding awards, such as, RGV911, FTA, TXDOT, and HHS.
- 2023 Annual Budget does not reflect an increase in Membership dues.
- 2023 Fringe Benefit rate is 50.88% and reflects an increase of 1.91% over the 2022 fringe benefit rate of 48.97%.
- 2023 (Total Budget Expenditure) Indirect Rate is 12.02%, reflecting the State's revised guidance for calculation. Utilizing the revised calculation method, the 2023 indirect rate reflects a decrease of 2.29% from the 2022 amount of 14.31%. As per Texas Local Government Code (Sec. 391.0115.e), an RPC may not spend an amount more than 15% of the commission's total expenditures, less capital expenditures and any subcontracts, pass-throughs, or subgrants.
- 2023 Salary Recommendations for staff includes a 3% performance-based salary increase for those employees who have successfully achieved all standards per the annual evaluation review process and a 2% labor market adjustment.

The Committee held a hybrid in-person/virtual meeting via GoToMeeting on January 12, 2023, to review the Annual Report and Budget. The Committee unanimously recommends approval of the 2023 Annual Report & Budget.

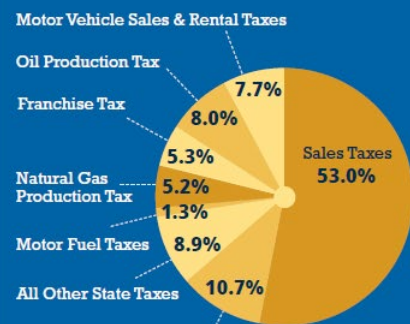

A. Community & Economic Development

Program Status Reports

- Economic Development Administration

Staff continue to meet with regional EDOs concerning the planning of projects that will provide economic impact. EDO's have been contacted to inform them on EDA Public Works and Economic Adjustment Act (PWEAA) funding availability. Staff have also been active with regional partners in area tours, getting first-hand views of project potential while meeting with all involved with potential project development, and working towards a regional group of economic development professionals that meet regularly to keep effective lines of communication.

Technical assistance continues to be provided to entities who are interested in applying for EDA grant, as well as hosting or co-hosting beneficial workshops and outreach. Staff also serve as the regional point of contact for the Economic Development Administration (EDA) and will continue to disseminate information accordingly. Staff also continue to coordinate efforts with other governmental entities on their economic development related activities in order to maximize benefit of all projects and objectives for the region and avoid any duplication of efforts and resources. Several different entities are conducting economic development outreach efforts, included TWDB, TxDot, Texas GLO, and others.

Staff are available to provide technical assistance, project development, and grant administration on EDA proposals and projects. For any assistance or information on EDA in general, contact Rick Carrera, rcarrera@lrgvdc.org.

- Pandemic Response

The economic resiliency plan is in the final draft stages. The draft is in the minor final adjustment stage which includes some case studies and examples of best practices undertaken by other regions given similar circumstances. The economic resiliency plan will stand as document information which will help actionable plans and serve as a starting point moving forward to alleviate some of those issues.

The LRGVDC continues to be proactive as a liaison between various governmental levels and stakeholders. Staff have had discussions with area EDOs on further potential initiatives to help with resiliency efforts including the recruitment and marketing efforts needed for new investment in the area. Staff have also brought together and coordinated efforts between governmental, workforce, higher education, and other entities to encourage collaboration on funding opportunities

and other initiatives to address workforce needs and other facets of local economic development. Participation in local area economic development groups continue as well to further provide regional efforts. Resiliency efforts for the regional tourism industry continues to be a focus also, utilizing Explore RGV as a springboard for marketing efforts. See the Explore RGV updates further in this report for details.

Staff continue with efforts in assisting the Texas General Land Office (GLO) with their economic development study that focuses on resiliency from natural disasters, which began earlier this year. Staff have advised and assisted the GLO on outreach efforts and will continue working with the GLO throughout the duration of the study and scope of work. Additionally, staff continue efforts with the National Weather Service on improving community resilience for areas normally hardest hit by weather events. Future meetings will be planned, and information will be shared accordingly.

- Regional Small Cities Coalition

- Explore RGV

Staff efforts to provide an improved app for this platform continue and despite technical difficulties the updates are near completion. Those efforts include the updated and improved application loaded on the platform for download by end users. The creative development on the improvements has been completed and staff is waiting to approve final version. Planning for a re-launch event is also in progress. In this initiative staff are also working with regional Convention and Visitor Bureau (CVB) to acquire their buy in the collaboration for mutual destination promotion and most importantly in reaching out across isles

Staff are working on promotional development to conduct an event where the revised, improved, and effective project will be presented to the general public, stakeholders, and tourism industry. Staff also continue to work with different regional airlines that have incoming flights to the RGV from different parts of the county as well as international markets. The intention is to partner up with the airlines to promote the product/project onboard, as well as to blitz and package with them to the final consumer. Staff are working with Dallas and Houston CVB to cross market destinations as staff feel the tourism markets are similar. Media outlets are also being contacted to ensure the launch event has exposure and coverage that creates additional massive awareness. Following these initiatives, the next steps will be to reach out to the commercial and private sector to attract the business community in association with Explore RGV. In addition, staff will incorporate as many travel industry participants as possible for a well-rounded

comprehensive, and complete travel reference.

- Community & Economic Development Assistance Fund

The Community Development Fund is the largest fund category in the Texas Community Development Block Grant program (CDBG). This fund is available through a competition in each of the 24 state planning regions. Although most funds are used for Public Facilities (water/wastewater infrastructure, street and drainage improvements and housing activities), there are numerous other activities for which these funds may be used. Eligible applicants are non-entitlement general purpose units of local government including cities and counties that are not participating or designated as eligible to participate in the entitlement portion of the federal Community Development Block Grant program (CDBG). Non-entitlement cities that are not participating in urban county programs through existing participation agreements are eligible applicants (unless the city's population is counted towards the urban county CDBG allocation). Staff have disseminated information on CDBG funding available to area communities and stakeholders and have been available for any questions related to the funding opportunities.

- Water Quality Program

Staff continues to educate the public on water quality issues with the theme of “Water and Wildlife” for the month of January. You can find educational social media postings on the LRGVDC Facebook page. Give a thumbs up or leave comment! Outreach efforts for this program also include staff attending in-person events. This allows for great C&ED program promotion to the community. Informational reading material and promotional items on water quality are distributed at these events.

Staff continue to support projects that provides water quality monitoring through four (4) stations placed in targeted locations. The monitoring stations provide real time data on nutrients including dissolved oxygen, conductivity/temperature, nitrate, and ammonium in the main drainage outlets to the coastal waters. Updates on this project occur on a regular basis, and progress on data collection and other aspects of this project are good.

Staff also continue to regularly communicate with representatives from the Texas Commission on Environmental Quality (TCEQ) as well as other entities involved in water quality initiatives to strengthen partnerships and generate further activities related to water quality and to highlight the importance of it to the region.

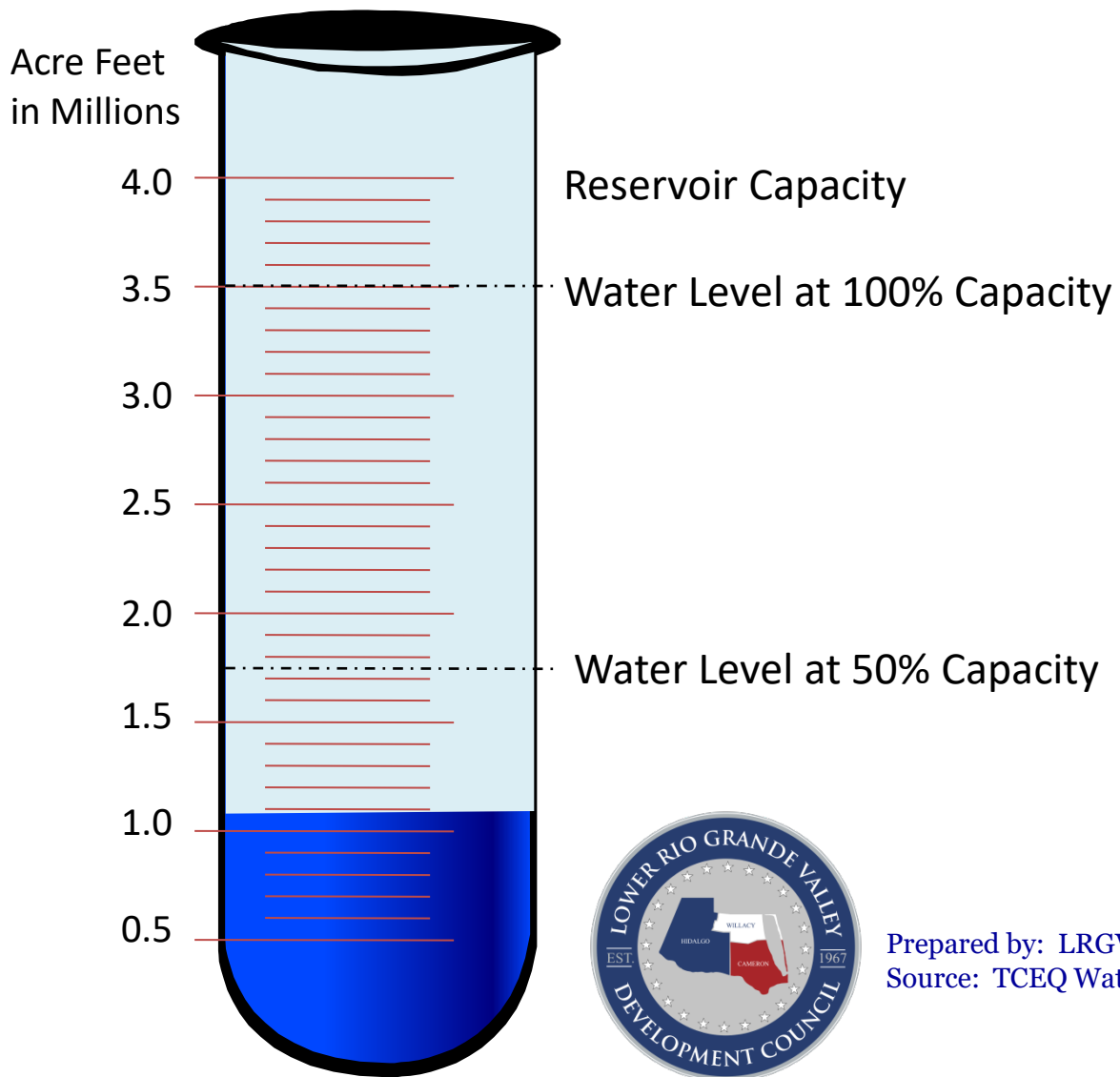
- Reservoir Levels

On January 14, 2023, the U.S. combined ownership at Amistad/Falcon stood at 32.16% of normal conservation capacity, impounding 1,090,850 acre-feet, down from 36.66%(1,243,328 AF) of normal conservation a year ago. Overall the system is holding 33.33% of normal conservation capacity, impounding 1,973,665 acre-feet with Amistad at 45.78% of conservation capacity, impounding 1,499,666 acre-feet and Falcon at 17.91% of conservation capacity, impounding 474,008 acre-feet. 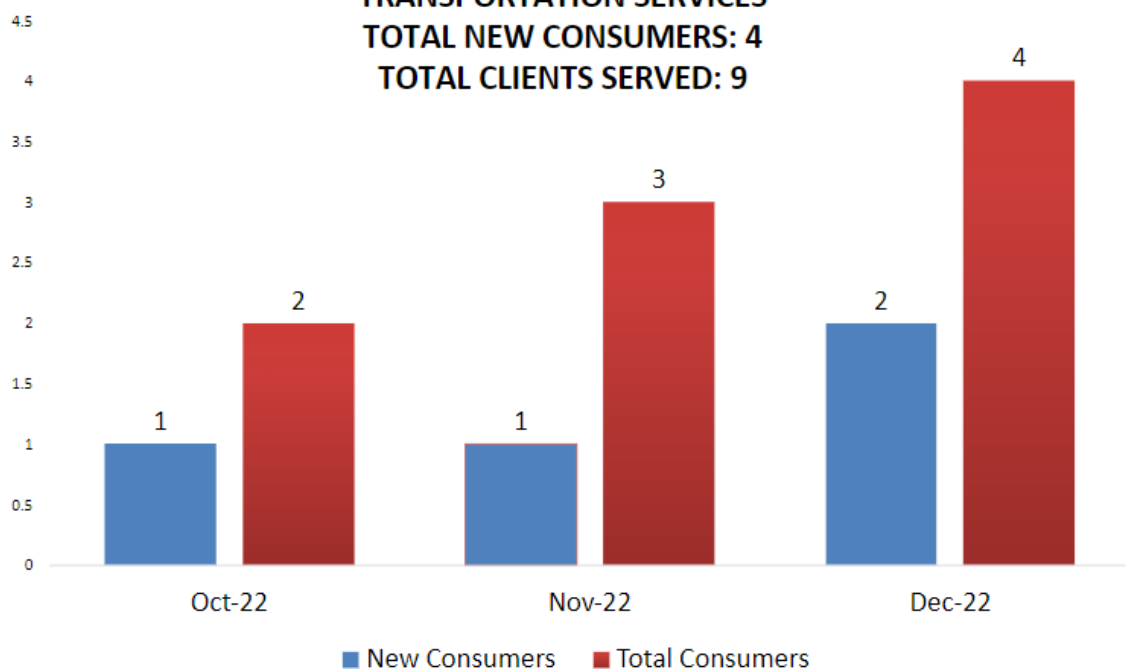

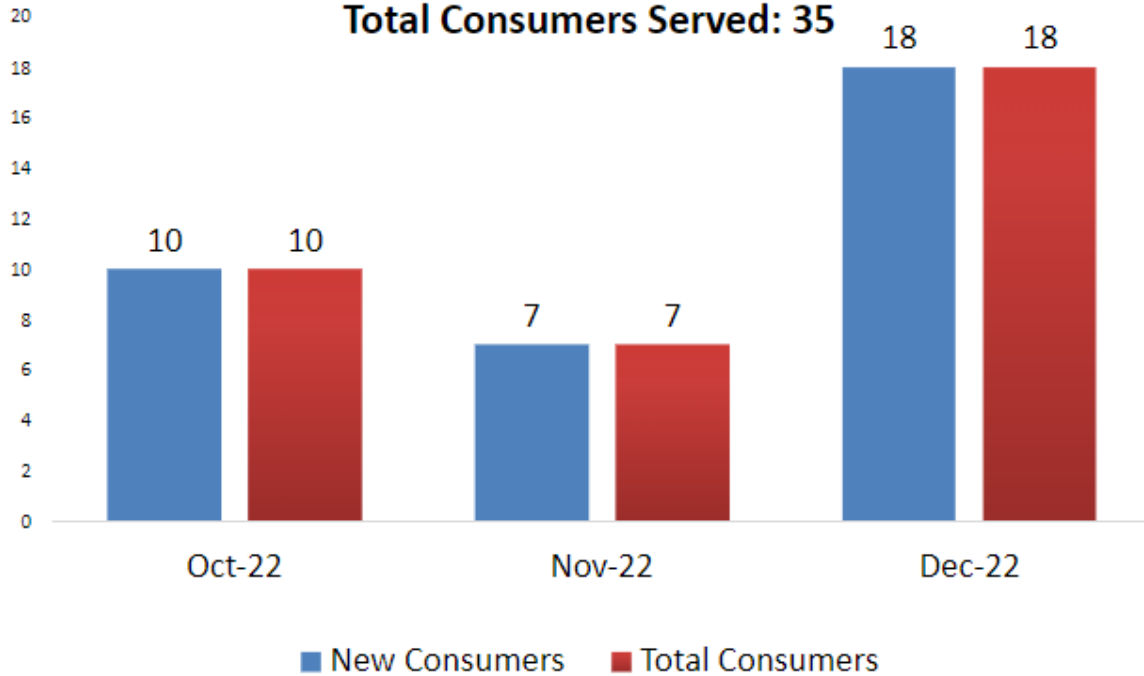

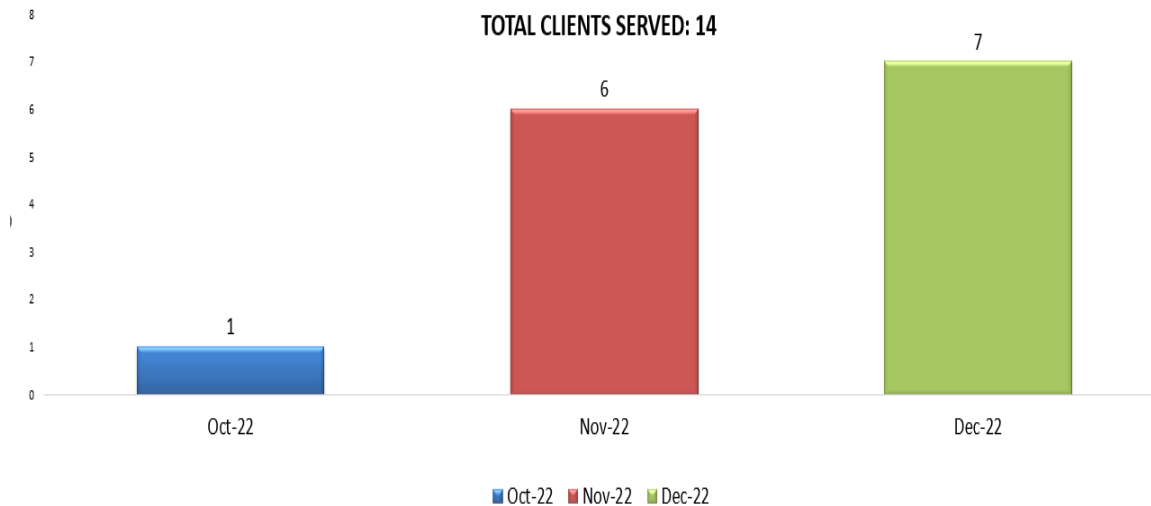

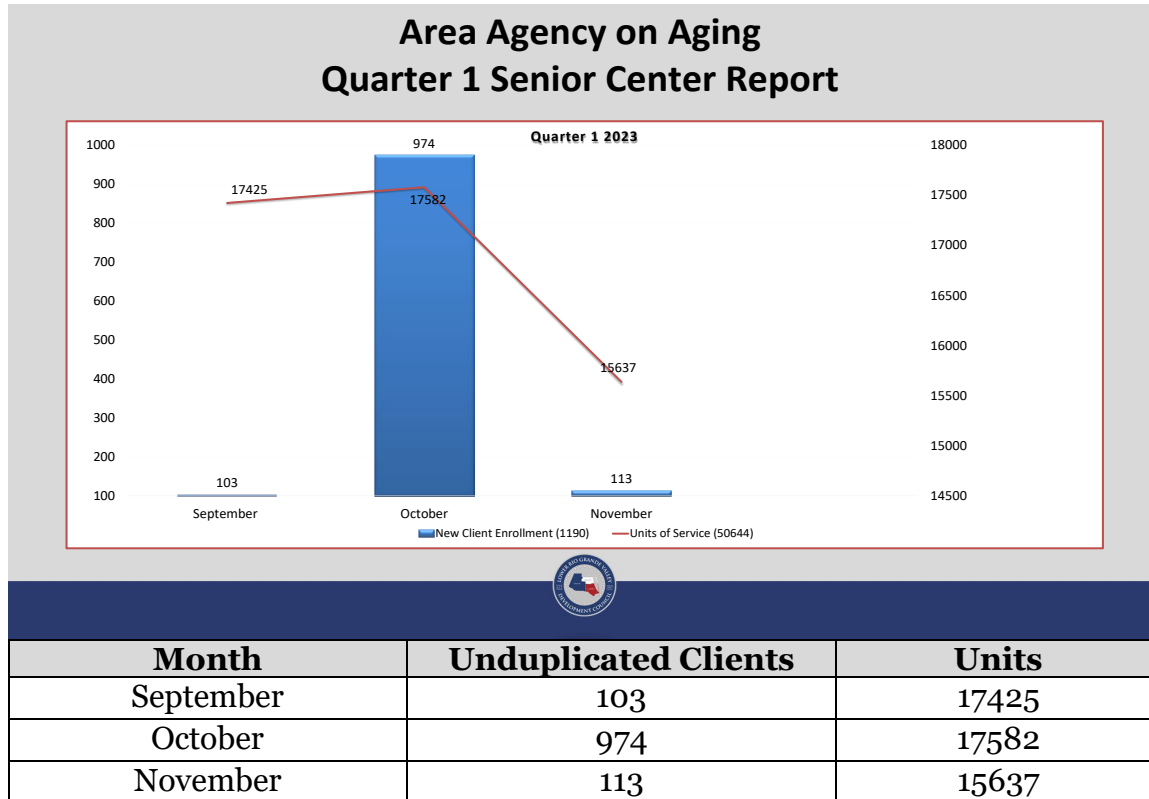

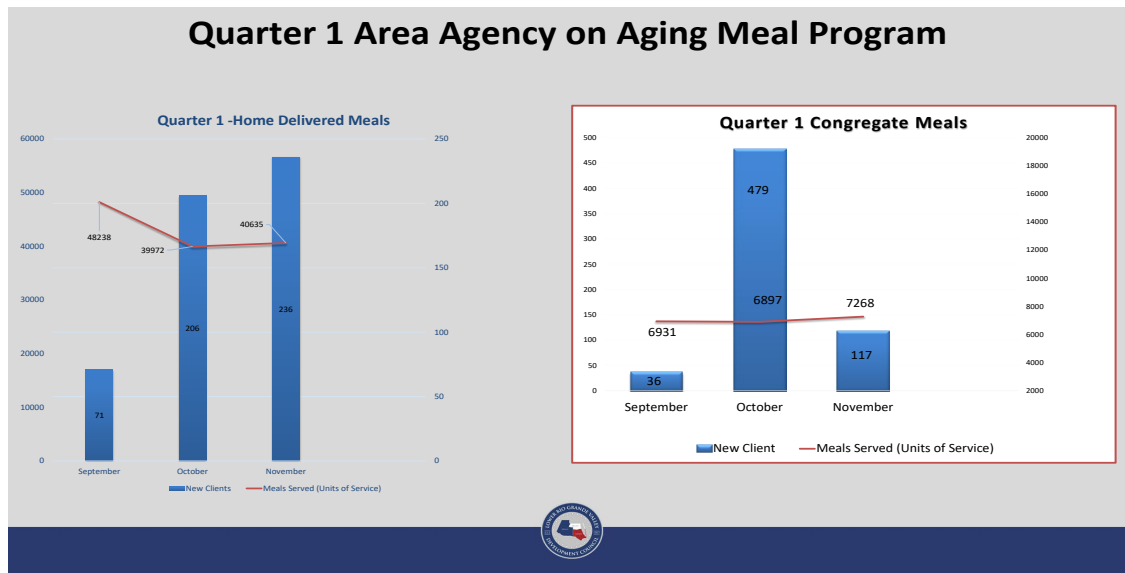

- Senior Subrecipient & Senior Center Operations for Fiscal Year 2022-2023



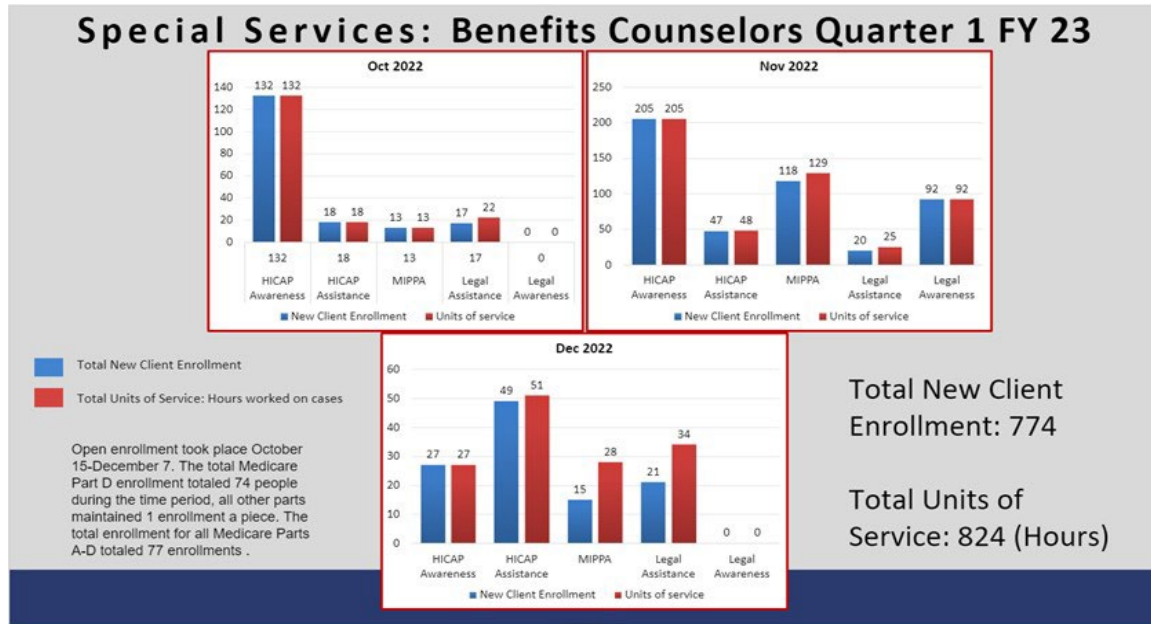
- Home Delivered and Congregate Meal Program for Fiscal Year 2022-2023



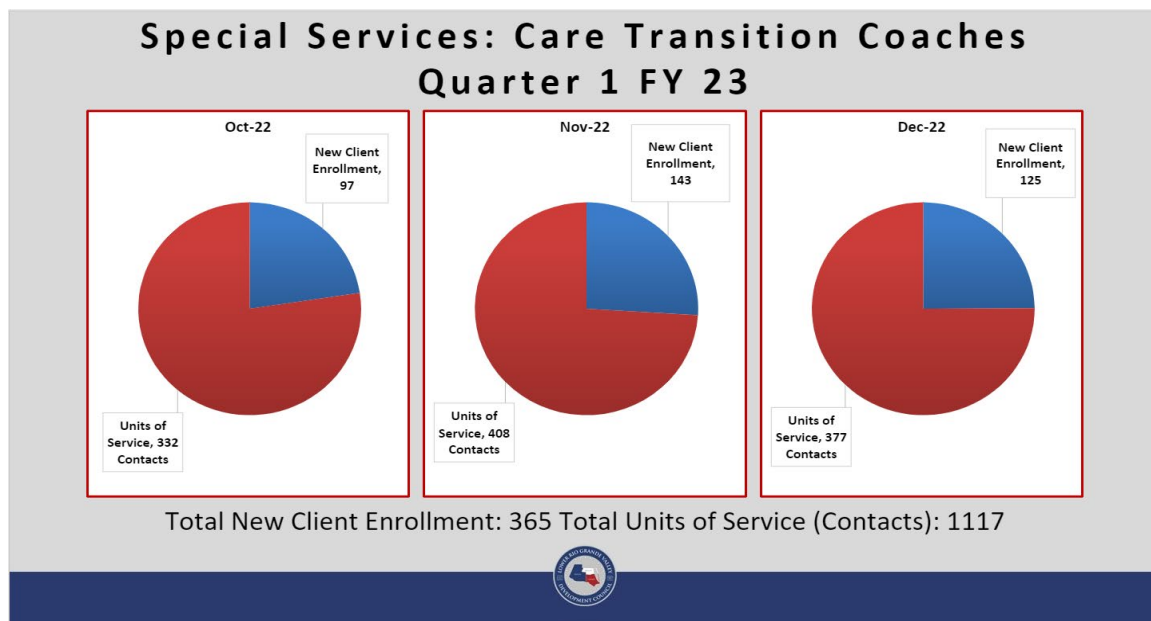

In a collaboration between Juan Esquivel, System Support Specialist from our I.T. team and Jacob Salinas, Program Specialist I from our GIS team we have completed our ArcGIS HUB-site creation. - Public Education Division

2022 was a successful and busy year for Public Education staff. Staff participated in more than 50 events in support of various agencies and schools. We work to keep public education thriving, and we are motivated when doing what we do best: Educate!

- 9-1-1 | Information Technology

Our 9-1-1 | Information Technology Team had a successful year in 2022. Our team accomplished VIPER (Voice over Internet Protocol Emergency Response) Ver. 7 Upgrade. With VIPER 7, this upgrade provides enhanced features and built-in tools to empower our telecommunicators to streamline 911 call handling operations. Our goal is to achieve 99.9% call-taking reliability/resiliency through our Communication District. To achieve this goal, we ensure our quarterly audits encompass calls and text tests, testing of our network failover, testing our PSAP generators, and testing our Uninterruptible Power Supply (UPS).

In the projects that we will be working on this year, we are looking to update our 9-1-1 Firewalls at our host sites. These firewalls can provide added layers of security to protect against new sophisticated threats. Second is our UPS upgrade project, these units are important to provide power during environmental utility issues which include spikes, brownouts, and power outages which is essential to run our 911 infrastructure for 24/7 operations. We will be splitting the project into 2 phases, the first will include larger PSAPs and the second phase will include all PSAPS. We are proud to continue our mission to better serve our community.

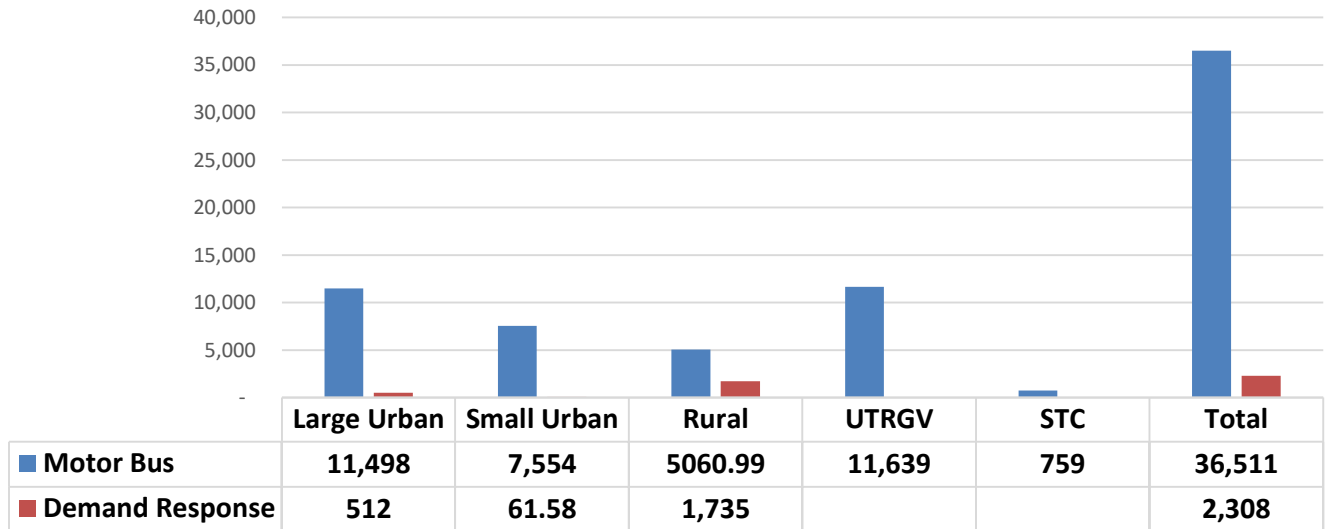

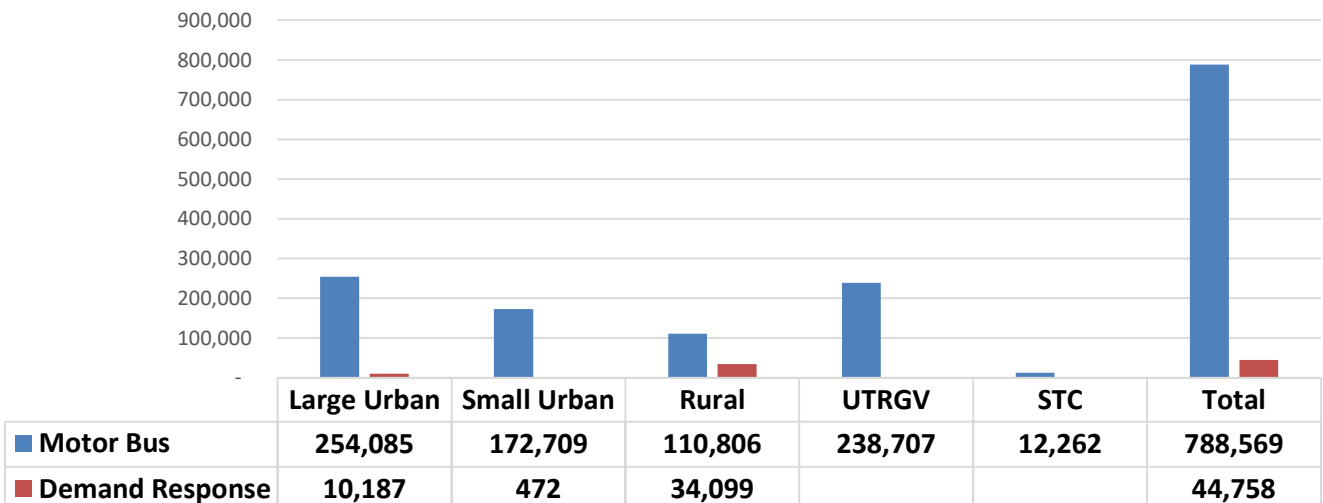
