MEETING OF THE LOWER RIO GRANDE VALLEY DEVELOPMENT COUNCIL BOARD OF DIRECTORS

PRESIDING: HON. NORMA G. GARCIA, PRESIDENT

President Norma G. Garcia called the meeting to order at 12:01 p.m. Roll call was taken and a quorum was declared.

The President then moved to item 2: Consider Approval of Meeting Minutes (February 27, 2019 Board Meeting). *Mr. Ron Mills made a motion to approve the minutes as presented. Willacy County Commissioner Eduardo "Eddy" Gonzales seconded and upon a vote the motion carried unanimously.*

President Garcia then moved to item 3: Public Comment and/or Report from Legislative Delegation there being none, she moved to item 4: Administration and recognized Executive Director Ron Garza to address the following:

A. Consider Approval of 2018 Annual Productivity Report

Mr. Garza stated that the Annual Productivity Report is a statutory requirement. Traditionally this has been done in two pieces, the first is the Annual Work Program & Budget that is presented to the Board every January, and the Annual Productivity Report is the second piece. He announced that for next year staff will combine the documents into one cohesive annual report containing projections and objectives. He stated that all objectives for 2018 recorded in the 2018 Annual Productivity Report have been met. *Mayor Tony Martinez made a motion to approve the 2018 Annual Productivity Report as presented. Mayor Rick Cavazos seconded the motion, and upon a vote the motion carried unanimously.*

B. Executive Director Report

1. Introduction of New Staff Members
Mr. Garza introduced Mr. Juan Lara, Part-time Fleet Fueler/Detailer for Valley Metro, and Mr.
Armando Perez, Administrative Assistant for Valley Metro. The Board warmly welcomed our new staff members to the LRGVDC.

LRGVDC Updates & Activities

2. Governor's (South Texas) Small Business Conference
Mr. Garza informed the Board that the Governor's Small Business Conference will be hosted by the
City of Edinburg on March 29, 2019 at the Edinburg Conference Center at Renaissance and will
combine small business resources from the public and private sectors.

3. 86th Legislative Session

The 86th Legislative Sessions is past the half-way point and today is the House Budget Debate. Mr. Garza stated that the Valley has had great participation in Austin with high attendance at RGV Day at the Capitol as well as many other individual Valley cities and counties representing their communities to our state legislators.

4. Regional Animal Control Initiative

Mr. Garza informed the Board that this group will soon revise their name to something that relates more to responsible pet ownership and care. At the All Hazards Conference tomorrow, March 28, there will be a session on this topic. One action item for this group is to create a resource website that would include a listing of animal centers and shelters throughout the Valley.

5. Road-to-Recycling Regional Tire Collection Day

Mr. Garza informed the Board that the 2019 Road-to-Recycling collection day is scheduled for Saturday, April 27. Staff is coordinating with municipalities and this year there will be three different options for disposal which he explained in detail.

6. It's Time Texas Community Challenge

Mr. Garza recapped the activities for the It's Time Texas Community Challenge and proudly announced the 2019 Winners from the Rio Grande Valley:

- ✓ McAllen took 1st Place, and Brownsville took 2nd Place in the Large City Category
- ✓ Harlingen took 1st Place, and Pharr took 3rd Place in the Mid-Sized City Category
- ✓ Los Fresnos took 1st Place, San Juan took 3rd Place, and Port Isabel took 5th Place in the Small City Category

He has hopes to sweep more categories in the 2020 Challenge and will continue to promote and encourage participation in this event.

7. Census Day RGV: One Year and Counting!

Mr. Garza informed the Board that the PSAP (Participant Statistical Area Program) process is wrapping up. The deadline for cities to make edits to their census tract splits is 4:00 pm on Friday, March 29. He also announced that on April 1, 2019, one year to the day prior to Census Day, April 1, 2020, two census events are scheduled: a press release is scheduled at 10:00 am at the Hidalgo County Courthouse in Edinburg for the western half of the Valley and at 2:00 pm in Brownsville at the Historic Market Square for the eastern half of the Valley. He also stated that the US Census Bureau in the Valley has many job openings that need to be filled.

Upon conclusion of Administration items, President Garcia moved to item 5: Department Reports.

A. Economic Development

Economic Development Status Reports

Economic Development Director Terrie Salinas was recognized and reported on the recent Regional Small Cities Coalition meeting in Rio Hondo and the Texas PACE County Workshops.

Explore RGV Status Report

Economic Development Assistant Director Blanca Davila was recognized and informed the Board that "Escape Itineraries" have been updated on the Explore RGV website. Different locations across the tri-county area, including urban and rural areas are featured in the six itineraries. Stakeholders can also find "Recommend a Location" on the website where they can include a destination that is currently not listed.

B. Community & Environmental Services

Community Development Status Report

Program Director Marcie Oviedo was recognized and informed the Board that the status reports on the HUD Disaster Recovery Housing Program were in the meeting packet for review.

Environmental Resources Status Report

Ms. Oviedo stated that the Solid Waste Program and Water Resources status reports were in the meeting packet for review. She reiterated that the 2019 Road to Recycling Tire Collection Project is scheduled for Saturday, April 27, 2019 and encouraged participation.

C. Health & Human Services

Area Agency on Aging Status Reports

Program Director Joe Gonzalez was recognized to address the following:

1. Consider Approval of Advisory Council Recommendations for Hidalgo County Representative Mr. Gonzalez informed the Board that the Advisory Council recommends Mrs. Maria Hurtado from Mission to represent Hidalgo County on the Area Agency on Aging Citizens Advisory Council. Her interest in issues regarding the elderly and her personal involvement with the elderly qualify her for this position. *Raymondville Commissioner Edward Gonzales made a motion to approve Ms. Maria Hurtado to fill the Hidalgo County vacancy on the Area Agency on Aging Citizen's Advisory Council. Mr. Ron Mills seconded the motion, and upon a vote the motion carried unanimously.* Upon conclusion of action Mr. Gonzalez noted that there are vacancies on the Advisory Council for representatives from the Cameron County area and asked the Board to consider nominees to fill these seats. He also gave the status report on the Aging and Disability Resource Center (ADRC) and the National Association of Area Agencies on Aging (n4a) Project.

D. Public Safety

President Garcia next recognized Public Safety Director Manuel Cruz to address the following items:

Criminal Justice Program Status Reports

Mr. Cruz informed the Board that the Criminal Justice Program status report was in the meeting packet for review.

Emergency Communications Status Report

Mr. Cruz noted that the Emergency Communications Program status reports were in the meeting packet for review.

Homeland Security Status Report

1. Consider Approval of Prioritization List for LETPA/SHSP Funding Mr. Cruz stated that at the March Homeland Security Advisory Committee (HSAC) meeting the FY 2019-2020 Homeland Security Grant Program, State Homeland Security Grant Program (SHSP)/Law Enforcement Terrorism Prevention Activities (LETPA) applications were reviewed and prioritized. He provided the prioritization list and stated that Board approval is required to move forward. Mr. Ron Mills made a motion to approve the prioritization list for LETPA and SHSP funding as presented. Mayor Pro-tem Pete Garcia seconded the motion, and upon a vote the motion carried unanimously.

2. Consider Approval of Revisions to Homeland Security Advisory Committee's (HSAC) Bylaws The HSAC convened on March 7 in accordance with the Office of the Governor's – Public Safety Office Inter-Cooperative Agreement to review and update the HSAC bylaws. *Mr. Paul Hernandez made a motion to approve the revisions to the HSAC bylaws as presented. Mayor Pro-tem Pete Garcia seconded the motion, and upon a vote the motion carried unanimously.* Upon conclusion of action Mr. Cruz noted that the Homeland Security Program status reports were in the meeting packet for review. He announced that the South Texas All Hazard Conference which began today was off to a great start with record breaking registration.

Regional Police Academy Status Report

- 1. Consider Approval of Police Academy Advisory Committee Members Mr. Cruz informed the Board that in accordance with Texas Administration Code, Title 37, Part 7, Rule 215.7, Training Academy Advisory Board and academy must maintain an Advisory Board as required by Texas Occupations Code 1701.252 which requires one-third of the members to be public members. The Advisory Committee recommends approval for Ms. Gloria Ocampo and Ms. Daisy Lopez to fill the vacancies in the Public Members category. Mayor Rick Cavazos made a motion to approve Ms. Ocampo and Ms. Lopez to fill the vacancies in the Public Members category as recommended by the Police Academy Advisory Committee. Member-at-Large Eddy Gonzalez seconded the motion, and upon a vote the motion carried unanimously.
- 2. Consider Approval of Updated Memorandum of Understanding with Partner Agencies These Memorandums of Understanding (MOU) have been updated for the Harlingen Police Department, Mission Police Department, Hidalgo Police Department and the San Benito Police Department. Mr. Cruz stated that these agencies assist with facilitating and instruction of the Regional Police Academy Basic Peace Officer Course, and that the documents were in the meeting packet for review. Mr. Troy Allen made a motion to approve the Memorandums of Understanding as presented. Commissioner David Garza seconded the motion, and upon a vote the motion carried unanimously.
- 3. Consider Approval of Inter-local Agreement between LRGVDC Regional Police Academy and Regional Police Agencies Requesting Training Hours

 The Regional Police Academy reports training hours to TCOLE for multiple agencies throughout the region. To maintain compliance with TCOLE and the Regional Police Academy Advisory Committee bylaws, this Inter-local Agreement will establish general guidelines for all agencies requesting that their training hours be reported by the Regional Police Academy to TCOLE. The agreement was provided to the Board in the meeting packet for review. *Mr. Ron Mills made a motion to approve the Inter-local Agreement between LRGVDC Regional Police Academy and regional police agencies requesting training hours.*
- 4. Consider Approval of Resolutions for Regional Law Enforcement Training Academy Grant Program FY 2020
 Mr. Cruz stated that in accordance with the Office of the Governor's Criminal Justice Grant Division, the LRGVDC is required to submit a resolution for this grant application. A copy of the resolution was provided for review. Commissioner Julian Guevara made a motion to approve the resolution as presented. Mayor Pro-tem Norie Gonzalez Garza seconded the motion, and upon a vote the motion carried unanimously. Upon conclusion of action Mr. Cruz noted that the regular status reports for the Regional Police Academy were in the meeting packet for review.

E. Transportation

Hidalgo County Metropolitan Planning Organization Status Report

HCMPO Assistant Director Linda De La Fuente was recognized and announced that the 9^{th} Annual Walk-N-Rolla event is scheduled for April 27, 2019. This year the proceeds of the event will go to the Laurie P. Andrews PAWS (Pet Adoption and Wellness Services) Center. Registration is \$15.00 or five cans of cat and/or dog food. The HCMPO will have an Open House at their office from 2:00 – 4:00 PM today, and another one tomorrow, March 28, and at the Pharr Library from 5:00-7:00 pm.

Valley Metro Status Report

Valley Metro Director Tom Logan was recognized and informed the Board that the regular status reports were in the meeting packet. He was proud to announce that year-to-date for the first six months of their fiscal year Valley Metro has transported 446,000 passengers which is a 16% increase in ridership. There have been 36,000 riders on the new Route 16, the Hidalgo County Court Circulator. Mr. Garza informed the Board that the Harlingen Terminal has been moved to the new "T" Street location and it has become a very busy terminal.

President Garcia next moved to item 6. – New or Unfinished Business. There being none, she called for a motion to adjourn. Raymondville Commissioner Edward Gonzales made a motion to adjourn, Mayor Jim Darling seconded, and the meeting was adjourned at 12:39 pm.

A. Economic Development

Economic Development Status Report...... Terrie G. Salinas, Director

Regional Small Cities Coalitions

This month's Regional Small Cities Coalition was hosted by the City of Los Fresnos. The RSCC was the first regional group to meet in their new, beautiful Emergency Services Building. Mr. Mark Milum, City Manager, invited us to come back in a few months when they open their new City Hall building which is just in front of this facility. Congratulations to the City of Los Fresnos.



This month's guest speaker was Ms. Enriqueta "Keta" Caballero, the Director of Border Affairs for Secretary David Whitley. The RSCC was also honored to have Deputy Secretary of State Joe Esparza speak at our meeting.

Mr. Esparza was sworn in as Texas Deputy Secretary of State on December 14, 2018 and accompanied Ms. Caballero to the RSCC Meeting. The Deputy Secretary and Ms. Caballero provided the Coalition with great information and resources for the Border region. The RSCC thanked Mr. Esparza for his time and service and invited him to come back soon.

In addition to Ms. Caballero's presentation, Mr. Rolando Vela provided an update on Legislative Issues and Mrs. Terrie Salinas provided updated reports on the 10th Annual Texas Rural Challenge, RGV Focus, Kari's Law Workshop, and the PACE Summits held in Willacy and Hidalgo Counties. Both PACE events were successful, and staff is helping Mrs. Heydinger with the upcoming summit for Cameron County. The Coalition and staff also thanked Ms. Nelda Barrera, Field Representative for Texas Department of Agriculture (TDA) for the free booth at the 80th Annual Rio Grande Valley Livestock Show. In addition to Kari's Law information, the Area Agency on Aging Department took advantage of this great opportunity to promote its program and services.

Readiness for Resilience Workshop

Staff also announced a very important event received from the Economic Development Administration (EDA) Regional Office. EDA has partnered with Texas A&M Agri Life Extension and others to promote the "Readiness for Resilience Workshop: A Smart Technology Roadmap for Texas".

"This two-day workshop is a continuation of their commitment to long-term community resilience through the Smart Technology Roadmap for Texas. Community stakeholders. Technology partners will convene and discuss post-Harvey regional project directions, case studies, public-private partnerships, and funding opportunities. This workshop will provide useful information in preparing for 'tomorrow's disaster'. A copy of the registration flyer is attached."

• Texas Rural Funders Collaborative

Lastly staff announced that an invitation to join the Texas Rural Funders Collaborative (TRFC) has been received. This group is made up of private foundations, community foundations, and health-conversion foundations that represent a variety of interests for rural areas. This group will identify relevant short and long-term strategies to pursue, including actionable information for other public and private organizations to use. They have already compiled research reports on rural Texas to start the conversation about the hard realities as well as rural success stories. The first meeting will be held May 7-8 in Austin.

Staff will work closely with Ms. Barrera who is also representing the Valley. For more detailed information, please contact Mrs. Salinas.

Kari's Law Project

The Economic Development Department is providing information on Kari's Law and 911 to businesses and public agencies in Hidalgo and Willacy Counties. For new Board members, Kari's Law is an amendment that was made to the "Communications Act of 1934 that requires most multi-line telephone systems to be pre-configured so users may call '911' without dialing any additional digit, code, prefix or post-fix, including any trunk-access code, such as the digit '9'. Additionally, a MLTS must be capable of sending alerts to a designated central point of contact either within the building housing the system or to an outside location".

This law does not wish to cause businesses and public agencies undue financial burden, but they must comply with Kari's Law and make sure their phone systems can provide direct access to 911. Secondly, this law is not only in Texas anymore, it is a "national law" therefore there is a penalty for failing to comply. According to this Legal Alert by Best, Best & Krieger, LLP, "Any 'willful and knowing' noncompliance may lead to a fine of up to \$10,000. Violators may incur additional penalties, including up to \$500 for each day of noncompliance.

Staff would also like to announce that April 14-20, 2019 is "National Public Safety Telecommunications Week" and we encourage our city and county officials to visit their Telecommunicators and thank them personally for their service. I called each of the PSAP Departments in our region and thanked them and emailed a thank you card addressed to the PSAP Supervisor on behalf of the LRGVDC Board and Economic Development Department (Kari's Law Project).

Your dispatchers and public safety telecommunicators are the unsung heroes in our everyday lives because they are the critical lifeline to other first responders. They serve as a vital link between your community and fire, medical, and law enforcement agencies and the work they do may one day end up saving your life or the life of your loved one.



On April 13, 2019, the U.S. combined ownership at Amistad/Falcon stood at 65.01% of normal conservation capacity, impounding 2,205,131 acre-feet, up from 61.43% (2,083,525 AF) of normal conservation a year ago. Overall the system is holding 50.10% of normal conservation capacity, impounding 2,967,199 acre-feet with Amistad at 60.64% of conservation capacity, impounding 1,986,240 acre-feet and Falcon at 37.06% of conservation capacity, impounding 980,959 acre-feet. Mexico has 30.12% of normal conservation capacity, impounding 762,067 acre-feet at Amistad/Falcon.

COTO de Casa is a non-profit organization under the Mission Housing Authority. The Advisory Council recommends approval to award the Housing Bond funds to COTO de Casa to provide housing repairs for seniors.

The Housing Bond funds are a result of housing corporations that collect a fee from loans to multi-housing developments. The fee is paid in lieu of a 5% housing unit set aside for older persons of low to moderate income including veterans, homeless persons, heads of households, or other older persons. The fee is paid to the Texas Health and Human Services Commission. The government code directs the funds to be used to obtain housing for older persons. The funds are made available to the Area Agencies on Aging and the amount of funds for the LRGVDC Area Agency on Aging is \$19,082.

A second round is set to be released before the end of April and all funds must be expended by August 31, 2019.

Emergency Communications Status Report

1. Consider Approval to Purchase Installation Services for Generators at Public Safety Answering Points (PSAPs)

As per LRGVDC procurement procedures, competitive sealed bids process solicited installation services for 13 generators at PSAPs.

The generators will provide backup power in the event of an electricity outage so PSAPs are able continue providing 9-1-1 services until power has been restored. The list of PSAPs receiving new generators is subject to change to a lesser amount pending evaluation of equipment and building specifications at some of the locations.

Solicitation of bids was conducted, and one qualifying bid was received. After further research and negotiations, the selected, recommended vendor is Loftin Equipment Co. which will provide installations services, equipment set-up, and engineering services to meet all building requirements and codes. Following Board approval, LRGVDC will enter into contractual services at an average cost of \$63,180 per unit.

This is a budgeted line item with the Emergency Communications/9-1-1 Program approved by the funding agency, CSEC.

LRGVDC policy requires Board approval for purchases exceeding \$25,000.

• Location Validation Program

Staff constantly generates address tickets, addresses new subdivisions and customer requests for 9-1-1 Physical Addresses in Hidalgo and Willacy Counties. Staff continues to meet with local cities to discuss annexations and discrepancies such as incorrect addresses as they arise.

During the month of March 2019, the department hosted its first Addressing Workshop. There were over 30 attendees which included Planning staff from our neighboring cities of Laredo, Eagle Pass, and Corpus Christi. Planning department staff from Cameron County and Hidalgo County also attended.

Database Program

Database staff updates the 9-1-1 database and adds new streets and ranges as new subdivisions are developed in Hidalgo and Willacy Counties. In March five Telephone Numbers (TN) were corrected, and fifty-five streets in the Master Street Address Guide (MSAG) were added/updated. Also, over 350 address request calls were received which resulted in 322 address tickets for 9-1-1 physical addresses. Staff also updates the No Record Found (NRF) list received from West Inc. daily. The NRFs are those telephone numbers that dial 9-1-1 and no record shows in the 9-1-1 system.

Additionally, staff validates 9-1-1 physical addresses for West Inc. on the new VOIP (Voice Over Internet Protocol) TNs being issued in this Region. This process is performed because it is the telephone company's responsibility to validate a phone number's physical address before issuing them to customers.

Mapping Program

Mapping Program staff has transitioned all 9-1-1 physical address data to the new State approved EGDMS Schema; this change is vital to the future of 9-1-1 call routing. It has been implemented at the LRGVDC 9-1-1 office as well as the host sites at McAllen PD and the Hidalgo County Sheriff's Office. The EGDMS 3 project has started and we have completed our initial data load. Staff continuously works on address point verification to ensure accurate call routing in the new I-3 9-1-1 Environment. Mapping staff received training on publishing

data on the internet which will better our understanding of ArcGIS online. Staff also continues to update address information on our local maps. We are continuing our efforts in training staff to become more efficient and are focusing heavily on expanding our GIS web presence.

System and Public Safety Answering Point (PSAP) Operations

Systems staff continues monitoring our PSAP sites. Installation of a third Host site at our Weslaco facility that will create a segregated network. Systems staff has also acquired Amp for Endpoints and Umbrella to increase our 9-1-1 office cybersecurity network. Systems team has begun the process of moving equipment from Mercedes PD PSAP to its new home at the Weslaco PD colocation facility at 1912 Joe Stephens Ave. in Weslaco. Systems staff is in the process of upgrading PSAP front room equipment at each of our 18 PSAPs.

• Public Education/Training Program

Public Education is an ongoing priority for the Emergency Communications 9-1-1 Division and staff continues to reach out to communities to educate residents. The 9-1-1 Division distributed 10,978 promotional items in March.

Homeland Security Program

At the April 4, 2019 Homeland Security Advisory Committee meeting the committee celebrated its 15th anniversary. Since 2004 the HSAC has been instrumental in strengthening our region's ability to protect, prevent, mitigate, respond to, and recover from those greatest threats and hazards to the RGV communities. KRGV Channel 5 News was also honored with a plaque as a token of appreciation for their financial contributions to the Regional Interop Communications fund. Mr. John Kittleman, General Manager, accepted the plaque on behalf of KRGV Channel 5 News.

Juanita Saenz, Program Supervisor for Homeland Security & Criminal Justice Programs, has been invited to serve on the Texas Public Safety Training Strategic Advisory Group; the group is an initiative of the Office of the Texas Statewide Interoperability Coordinator Office. The purpose of this group is to update training materials for radios and outreach mechanisms that will promote interoperability.

Staff hosted a Bomb-Making Material Awareness Program (BMAP) Community Liaison course on April 23, 2019 at the LRGVDC. The course enhances public safety and the security of all Texans by educating retailers about HME and IED materials and ingredients; raising awareness of suspicious purchasing patterns; and preventing terrorist use of HMEs and IEDs in the state.

Staff continues to provide technical assistance to jurisdictions with Emergency Management Plans (EMPs) and identify training opportunities for regional first responders. Staff is also working on purchasing equipment for some of the area's first responders via recent grant awards and continues to manage the fire coordinator grant-funded position for the Emergency Training Alliance Board Fire Academy #50 which is currently underway.

Staff assisted in hosting the annual Public Safety Communications Focus Group session and completed the workbooks to update our status of interoperable communications. The purpose of this effort is for public safety communications stakeholders in our region to work together to review goals of interoperable communications and the progress toward them and to discuss regional focus for the coming year(s).

The region's input is a valuable part of the annual Texas Department of Safety Report on Interoperable Communications to the Texas Legislature.

• Citizen Corps Program (CCP)/Community Preparedness

Staff continues to promote its community preparedness campaign, Ready RGV!, which can be found online at www.readyrgv.org. Staff promoted Ready RGV! at the Human Trafficking Conference held at the STC-Pecan campus in McAllen on April 2, 2019.

Regional Police Academy Status Report

• In-Service Training

The Regional Police Academy continues to offer in-service training throughout the region. During the timeframe of March 18—April 12, 2019 the Regional Police Academy has facilitated training in the area of Civilian Interaction, Intermediate Use of Force, Intermediate Arrest Search and Seizure, and Verbal De-Escalation. The Regional Police Academy will be conducting the Civilian Response to Active Shooter at La Feria ISD in May at their request. This training will occur over three days.

Grant Writing USA Workshop

Bringing training to the region remains a priority for the Regional Police Academy. The Academy is currently coordinating with Grant Writing USA to bring their training on grant writing and grant management to the region. The grant writing workshop will be offered in June or July and will be followed by grant management in September or October. In coordination with the Edinburg Police Department and TEEX, the 40-hour course of Intermediate Defensive Tactics will be held in Edinburg in July.

Additional Training Courses

As the Academy receives requests we will continue to build, host, and instruct courses. Additional courses currently being scheduled are Firearms Instructor, Advanced TCOLE Instructor, Field Training Officer, and Radar Instructor.

• Report on Current Academies

The 199^{th} Night Academy and 200^{th} Day Academy are still in process and is progressing on schedule. Testing is in progress for the 201^{st} Day Academy and the 202^{nd} Night Academy. The 201^{st} has a tentative start date in August 2019 while the 202^{nd} has a tentative start date in January 2020.






Valley Metro Service Summary FY 2019 September - March


















Distribution of Revenue Hours


