Commissioner David Garza made a motion to approve the slate of the three (3) members-at-large as presented and recommended by the Nominating Committee to serve on the Board of Director. Commissioner Abiel Flores seconded the motion, and upon a vote the motion carried unanimously.

President Hernandez next moved to Item 4. B. – Board Member Recognition. Mr. Manuel Cruz was recognized and stated that he has a plaque for former Brownsville Mayor Trey Mendez in recognition of his four (4) years of service on the LRGVDC Board of Directors and Executive Committee. Mr. Mendez was not present; however, Mr. Cruz will present his plaque in person at the earliest opportunity. Mr. Cruz next presented a gavel plaque to President Ambrosio "Amos" Hernandez for his year of leadership, hard work, and dedication for his service as Board President this past year. President Hernandez thanked his colleagues and LRGVDC staff for this recognition.

President Hernandez next moved to item 4. C. – Executive Director Report and recognized Mr. Cruz. Mr. Cruz stated that as many here may already be aware, our region has been designated as the Broadband South Texas Regional Working Group (STRWG). The Regional Working Group coverage map was displayed on the screen and Mr. Cruz pointed out that the STRWG region is quite large, it extends from Eagle Pass down to Brownsville and up to Corpus Christi. Mr. Cruz informed the Board that he has been appointed Co-Chair along with Ms. Emily Martinez, Director of Regional Economic Development for Coastal Bend Council of Governments (CBCOG). Mr. Cruz extended an invitation for Board Members to volunteer and/or recommend additional members to join the STRWG. The memo with information on this invitation that was recently emailed to the Board was also provided in the meeting packet as a reference.

Mr. Cruz next introduced Mr. Cesar Merla, formerly of the Health & Human Service Department, and now the Assistant Director of CJD/HLS in the Public Safety Department, the return of Mr. Tom Logan as the Interim Director of Valley Metro, Mr. Hector Martinez who is now an Accounting Tech with the Valley Metro Department, and Mr. John Gonzales, Mr. Juan Murillo, and Mr. Alfredo Sanchez who are all now Vehicle Drivers with Valley Metro.

Mr. Cruz stated that a report of Legislative Bills that the Texas Association of Regional Councils (TARC) is tracking is available for review in the meeting packet.

Mr. Cruz thanked the Regional Water Resource Advisory Committee (RWRAC), the Board of Directors, the Stormwater Task Force, and sponsors: COSTEP, Island Metro, American Flood Coalition, Guzman and Munoz, MGV, and LRGVDC staff from Area Agency on Aging, Community & Economic Development, and the RGV9-1-1 District for the success of the Elected Officials Retreat. The retreat was held in conjunction with the Stormwater Management & Planning Conference held May 21-26 at the South Padre island Convention Center. The Elected Officials Workshop was scheduled on Wednesday, May 24 during which the "Lightning Round" was held. There were many 10-minute presentations by local, state, and federal agencies that highlighted various aspects of flood mitigation and recovery on which they focused. Mr. Jim Darling, Commissioner David Garza, and Judge Aurelio Guerra all commented on the success of this event.

Upon conclusion of Administration items, President Hernandez moved to Item 5. - Department Reports,

A. Community and Economic Development Department

### Program Action Item

1. Consideration and Action to Approve Professional Service Agreement for Economic Development Administration (EDA) Grant Administration

Mr. Cruz was recognized and informed the Board that staff requests approval of the agreement by and between the LRGV Economic Development District and Harlingen EDC. The LRGVDC will provide grant administration services specified in Part II Scope of Services of the Professional Service Agreement to the Harlingen EDC for their award from the EDA on their Industrial Park at Roosevelt in

Harlingen for Commercial and Community Benefits Project. Councilman Johnny Garcia made a motion to approve the Professional Service Agreement for Economic Development Administration grant administration as presented. Mayor Rick Guerra seconded the motion, and upon a vote the motion carried unanimously.

## 2. Update on Economic Recovery & Resiliency Plan

Mr. Cruz was recognized and reminded the Board that back in December 2021 the LRGVDC issued a Request For Proposals (RFP) to identify a professional consultant firm to complete an Economic Recovery & Resiliency Plan. The firm of Thomas P. Miller and Associates (TMPA) was hired to complete this plan and staff was able to use funding support from the Federal Economic Development Administration (EDA) via the CARES Act Recovery Assistant grant to help the region respond to the COVID-19 pandemic and other disasters. The Scope of Work outlined in the plan was to enable the LRGVDC to develop a recovery and resiliency plan that will help the region anticipate, mitigate, and respond to future economic disruptions. The Plan has been completed and is being provided for review as a status update. Staff will use this in conjunction with the upcoming Comprehensive Economic Development Strategy (CEDS) as required by the EDA. The plan in its entirety will be available for review and/or download on lrgvdc.org. No action needed.

### **Program Status Reports**

The monthly status reports are in the meeting packet for review. Mr. Jim Darling was recognized and gave the reservoir level report noting that currently the reservoirs are now *up* from the levels reported a year ago.

### B. Health & Human Services

Ms. Margarita Lopez, Director of Health & Human Services was recognized to address the following:

Ms. Lopez informed the Board that subrecipient contracts are funded under Title III of the Older Americans Act as amended and as per the State General Revenue (SGR) funds timeline. Commissioner David Garza made a motion to approve the Subrecipients' RFP timeline for fiscal year 2023-2024 as presented. Mr. Troy Allen seconded the motion, and upon a vote the motion carried unanimously.

Ms. Lopez summarize the program services staff provided during the month of April. Additionally, she was happy to report that staff receive notice that the LRGVDC Area Agency on Aging is now second in the State of Texas for providing specialized services for veterans.

Mr. Cesar Merla, CJD/HLS Assistant Director noted that the status reports were in the meeting packet for review, and he highlighted the Cybersecurity Incident Workshop hosted by staff on April 20. A total of 65 Cybersecurity IT professionals gathered in this room bringing awareness of this issue and highlighting the important of cybersecurity.

## D. Transportation

## Valley Metro Status Reports

Mr. Tom Logan, Interim Director of Valley Metro was recognized and provided the Ridership Report for April which shows 63,632 passenger rides which is a slight increase from the previous month. The Regional Transportation Advisory Panel (RTAP) continues to meet with stakeholders to discuss the 5-Year Plan. Outreach efforts continue by informing the public about transportation services that are available throughout the Valley; not only with Valley Metro, but also with Metro McAllen, Brownsville Metro, and Island Metro.

### Rio Grande Valley MPO Status Report

Mr. Andrew Canon, RGVMPO Executive Director was recognized and informed the Board that today is the deadline to submit applications for Transportation Alternatives grant program. He added that the new Carbon Reduction Program (CRP) has been placed on this afternoon's Policy Board agenda for consideration of approval. This would provide \$26 million over the next four (4) years for projects such as truck parking, trail systems, replacing street lighting and traffic control devices with energy-efficient alternatives, and other things of that nature that will reduce the carbon footprint. Lastly, Mr. Canon announced that a Meet & Greet is scheduled for tomorrow, June 1, from 2:00 pm – 4:00 pm at the Pharr District Office and encouraged Board Members to attend.

## Texas Broadband – Survey Extension

On Thursday, June 15<sup>th</sup> we received welcoming news of the BDO's decision to extend the <u>public survey</u> <u>deadline</u>. It will remain open through August 31<sup>st</sup>.

According to Connect Texas, we have doubled the number of survey responses and continue to hear from more Texans about their barriers to digital opportunities. In addition, with the new deadline for the survey open through August, the state's Digital Opportunity Plan is now due to NTIA in December. ## **Program Action Item**

 Consideration and ACTION to Approve Resolution 2023-03 in Support of Mexico Paying their Water Debt and Request Counties, Cities, and Water Entities to Approve a Similar Resolution

The Rio Grande Regional Water Planning Group (RGRWPG) (Region M) met on June 7, 2023, and discussed the water debt that Mexico as accrued. Mexico consistently has not met its delivery obligations and has delivered minimal volume in the current cycle since it began October 25, 2020. The United States' share of water in the Amistad and Falcon international reservoirs is at a very low level influenced by lack of deliveries from Mexico. Last summer, the U.S. share of water in the international reservoirs hit a low of 20.69% (701,729-acre feet) with the record low being 19% in 1998. The US share, as of June 3, 2023, is 31%. The summer forecast is not positive for further rainfall, and it will not take long for the reservoirs to reduce to 20% or lower (at 20% Cities conservation ordinances take effect resulting in development limitations and agricultural water supplies are minimal causing difficulty to deliver raw water for municipal treatment). Since August 2022, Mexico has accumulated over 2.9-million-acre feet in the reservoirs on the tributaries that the US should be receiving runoff from. As of June 3, 2023, Mexico is behind in their prorated deliveries to the United States by over 550,000acre feet.

At the June meeting, Region M took unanimous action to approved writing letters to legislators asking for their support in requesting from Mexico the delivery of water to the United States in accordance with the terms of the 1944 Treaty. In addition, Chairman Jim Darling, as a member of the LRGVDC Executive Committee presents the attached resolution for approval to further strengthen this request. Further, Mr. Darling recommends approval to send a similar resolution to counties, cities and water entities for their consideration and approval.

- **WHEREAS,** The Lower Rio Grande Valley Development Council (LRGVDC) is the Regional Council of Governments for Cameron, Hidalgo, and Willacy Counties; and,

Technical assistance continues to be provided to entities who are interested in applying for EDA grants, and the Economic Development District (EDA) is also currently providing grant administrative services to two projects. Staff also serves as the regional point of contact for the EDA and will continue to disseminate information accordingly. Staff also continues to coordinate efforts with other governmental entities on their economic development related activities to maximize benefits of all projects and objectives for the region and avoid any duplication of efforts and resources.

The EDA has published a new Fiscal Year 2023 Public Works and Economic Adjustment Assistance (PWEAA) Notice of Funding Opportunity (NOFO), Notice of Funding Opportunity (grants.gov link). The Public Works program provides resources to meet the construction and/or infrastructure design needs of communities to enable them to become more economically competitive. Supported activities under EDA's EAA program include construction and non-construction such as construction or upgrading of public infrastructure, sectoral partnerships for workforce training, design and engineering, technical assistance, economic recovery strategies, and capitalization or re-capitalization of Revolving Loan Funds (RLF). There are no application submission deadlines and applications will be accepted on an ongoing basis. Visit the following links for more information on this funding opportunity, Public Works, Economic Adjustment Assistance.

EDA has published a FY23 EDA Disaster Supplemental Notice of Funding Opportunity (NOFO), Notice of Funding Opportunity (grants.gov link). The Economic Development Administration (EDA) is providing support to those communities impacted by natural disasters in 2021 and 2022. The awards made under this NOFO are designed to address economic challenges in those areas where a Presidential declaration of a major disaster has been issued. Funding will help communities devise and implement long-term economic recovery strategies through a variety of construction and non-construction projects. ## • Community & Economic Development Assistance Fund

The Community Development Fund is the largest fund category in the Texas Community Development Block Grant (CDBG) program. This fund is available through a competition in each of the 24 state planning regions. Although most funds are used for Public Facilities (water/wastewater infrastructure, street and drainage improvements and housing activities), there are numerous other activities for which these funds may be used. Eligible applicants are non-entitlement general purpose units of local government including cities and counties that are not participating or designated as eligible to participate in the entitlement portion of the federal CDBG program. Non-entitlement cities that are not participating in urban county programs through existing participation agreements are eligible applicants (unless the city's population is counted towards the urban county CDBG allocation). Staff have disseminated information on CDBG funding available to area communities and stakeholders and are available to respond to questions related to the funding opportunities. The deadline for application submission was May 3, 2023. Applications will be scored, and a list of awardees will be provided by TDA once finalized.

## Water Quality Program

Staff continues to educate the public on water quality issues with the theme of "Stormwater Prep" for the month of June. You can find educational social media postings on the LRGVDC Facebook page. Give a thumbs up or leave a comment! Outreach efforts for this program also include staff attending in-person events. This allows for great C&ED program promotion opportunities for the community. Informational reading material and promotional items on water quality are distributed at these events.



Staff continue to support projects that provide water quality monitoring through four (4) stations placed in targeted locations. The monitoring stations provide real time data on nutrients including dissolved oxygen, conductivity/temperature, nitrate, and ammonium in the main drainage outlets to the coastal waters. Updates on this project occur on a regular basis, and progress on data collection and other aspects of this project is good.

Staff also continues to regularly communicate with representatives from the Texas Commission on Environmental Quality (TCEQ) as well as other entities involved in water quality initiatives to strengthen partnerships and generate further activities related to water quality and to highlight the importance of it to the region.

• Rio Grande Regional Water Planning Group (Region M)
At their June 7 meeting, the Region M Water Planning Group authorized
Chairman Jim Darling to write to legislators regarding the lack of water releases
from Mexico. Mexico is required, as per the 1944 Treaty, to release 1,750,000 acrefeet during a 5-year cycle (a minimum of 350,000 acre-feet annually). Mexico is
currently behind in their prorated deliveries to the United States by over 550,000
acre-feet and by writing to legislators the Group hopes they will be able to persuade
Mexico to release the water they owe.



## • Reservoir Levels

On June 17, 2023, the U.S. combined ownership at Amistad/Falcon stood at 30.66.% of normal conservation capacity, impounding 1,039,791 acre-feet, up from 27.91% (946,790 AF) of normal conservation a year ago. Overall the system is holding 29.24% of normal conservation capacity, impounding 1,731,934 acre-feet with Amistad at 34.11% of conservation capacity, impounding 1,117,213 acre-feet and Falcon at 23.22% of conservation capacity, impounding 614,722 acre-feet. Mexico has 27.35% of normal conservation capacity, impounding 692,144 acre-feet at Amistad/Falcon.

## **Regional Police Academy**



#### GIS Division

Our GIS Data Hub is now our primary website and can be found at www.rgv911.org. The GIS team has uploaded several informational maps that other public entities and the public can readily download. This data has streamlined our general information request process. We began creating a map that will aid our local fire departments establish better boundaries and an emergency service response. We will do the same for local EMS providers with 9-1-1 answers in the RGV9-1-1 region. In June, GIS team members Rosemary, Monica, and Joe attended the National Emergency Number Association (NENA) 2023 annual conference in Grapevine, Texas.

#### • Community Engagement Division

The events for this month highlight the efforts and achievements in educating and building a strong connection with communities. Community engagement is vital in teaching and promoting how to use 9-1-1 which can potentially save lives.

On May 24, 2023, Lyford ISD held a Career and Fair Day at Lyford High School. This exciting event brought together high school students and professionals from various fields and provided a unique opportunity for students to explore their future career paths. We thank Lyford ISD for inviting our RGV9-1-1 GIS Team to participate in this event. Our team mentored students in possible careers in the 9-1-1 department. #### 9-1-1 | Information Technology

On April 20, 2023, RGVECD's Information Technology team participated in the LRGVDC Cybersecurity Incident Planning exercise in collaboration with the Department of Homeland Security and various regional/local agencies. The exercise had our team assess foresight and strategic planning for Cybersecurity incidents. We learned methods to enhance how to handle these situations and improving our ability to respond, mitigate and recover from such an event by establishing solid standard operating procedures.

#### Cybersecurity Case reference


On June 6, 2023, it was reported that Federal agencies were breached by the largest Cyberattack in U.S. history by Chinese state-backed hackers. The bad actors could compromise Barracuda Networks' Email security gateway appliance deployed at many government agencies and corporations. This gave hackers access to data on thousands of computers worldwide. The realization that the very equipment designed to prevent these types of attacks is also at risk of being breached themselves.


On June 15, 2023, United States government agencies such as the Energy Department, significant universities, and NATO partners were breached by Russian hackers that exploited a file transfer application where data was stolen and exploited for ransom. These types of attacks steal data and information allowing hackers to threaten the release of these documents to the public or foreign adversaries if a ransom is not paid. The Cybersecurity and Infrastructure Security Agency (CISA) was notified and brought in to mitigate the damage caused by the Cyber-attack, which could result in millions of dollars.


Our IT team has also been preparing for hurricane season by ensuring that all the UPS backup systems and diesel power generators at the various PSAPs are fully


operational. We have worked diligently with our vendors, verifying that each unit is maintained correctly and in a functional readiness state.

We take these proactive measures to provide 99.9% reliability so that our organization is ready for any Cybersecurity threat, planned maintenance, or weather event that has the potential to disrupt operations. Our ongoing mission is to provide critical lifesaving 9-1-1 call delivery continuing our efforts to serve our public safety partners and the community.

#### Ridership Report

Valley Metro provides regional transportation service of both **Rural** and **Urban** transit systems in the five-county region of the Rio Grande Valley. The **Urban System** is provided in Cameron, Hidalgo, and Starr Counties and includes UTRGV Ridership. Services run Monday – Saturday from 6:00 am to 10:00 pm. The **Rural System** operates in the rural areas of Cameron, Hidalgo, Willacy, Starr, and Zapata Counties. Services run Monday – Sunday from 6:00 am to 9:00 pm.

Valley Metro met with TxDOT for the quarterly Financial Monitoring Review and a tour of the transit facility on June 8. Meetings were held with UTRGV, City of San Benito, Brownsville Metro, and Island Metro to discuss ongoing and upcoming transit projects.
