# CHAPTER 30 - MONTGOMERY GI BILL - ACTIVE DUTY - (MGIB - AD)

THE MGIB-AG PROGRAM (SOMETIMES KNOWN AS CHAPTER 30) PROVIDES EDUCATIONS BENEFITS TO VETERANS & SERVICE MEMBERS WHO HAVE AT LEAST TWO YEARS OF ACTIVE DUTY. THIS EXCLUDES VETERANS WITH A GENERAL UNDER HONERABLE CONDITIONS DISCHARGE.

### **CHAPTER 33- POST 9/11 GI BILL**

APPLICANTS MUST HAVE AT LEAST 90 DAYS OF AGGREGATE ACTIVE-DUTY SERVICE AFTER SEPTEMBER 10, 2001, AND ARE STILL ON ACTIVE DUTY. APPLICANT MAY QUALIFY WITH AN HONORABLE DISCHARGE OR A DISCHARGE WITH A SERVICE-CONNECTED DISABILITY AFTER 30 DAYS. CHILDREN OF DECEASED SERVICE MEMBERS WHO BECOME ENTITLED TO THE POST 9/11 GI BILL ON OR AFTER JANUARY 1, 2013 & ALL SPOUSES USING THE FRY SCHOLARSHIPS NO LONGER HAVE A TIME LIMITATION TO USE THEIR BENEFITS.

## **CHAPTER 35 - SURVIVAL & DEPENDENT ASSISTANCE**

THE FOLLOWING PROGRAM OFFERS EDUCATION & TRAINING OPPORTUNITIES TO ELIGIBLE DEPENDENTS OF VETERANS WHO HAVE A SERVICE-CONNECTED PERMANENT AND TOTAL DISABILITY OR DIED AS A RESULT OF A SERVICE CONNECTION.

# CHAPTER 1606 - MONTGOMERY GI BILL - SELECTED RESERVE (MGIB -SR)

THE FOLLOWING PROGRAM OFFERS EDUCATION & TRAINING OPPORTUNITIES TO ELIGIBLE MEMBERS OF THE SELECTED RESERVE, INCLUDING THE FOLLOWING RESERVE BRANCHES, ARMY, NAVAL, AIR FORCE, MARINE CORPS, COAST GUARD, ARMY NATIONAL GUARD, AND THE AIR NATIONAL GUARD. ELIGIBILITY FOR THIS PROGRAM IS DETERMINED BY THE DEPARTMENT OF DEFENSE AND THE DEPARTMENT OF HOMELAND SECURITY. PAYMENT FOR THIS PROGRAM IS DISTRIBUTED BY THE VA.

### CHAPTER 1607 - RESERVE EDUCATIONAL ASSISTANCE PROGRAM (REAP)

THE FOLLOWING PROGRAM OFFERS EDUCATION & TRAINING OPPORTUNITIES TO ELIGIBLE MEMBERS OF THE RESERVE COMPONENTS OR THOSE WHO ARE ORDERED TO ACTIVE DUTY IN RESPONSE TO A WAR OR NATIONAL EMERGENCY DECLARED BY THE PRESIDENT OR CONGRESS.
